

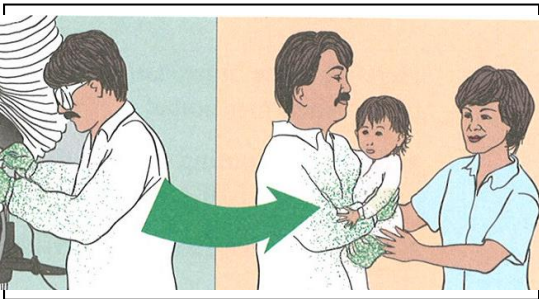
Uncontained Paint Removal is Against the Law

Disturbing or removing pre-1978 paint without safe work practices can be extremely hazardous to workers, occupants and neighbors and can contaminate the property.

Under California law, it is unlawful to use work practices that create a lead hazard and contaminate the environment.

Under Federal EPA rules, anyone conducting renovation, repair, or painting work for compensation, in pre-1978 buildings, including landlords, must be trained, certified and use lead-safe work practices. For more information go to www.epa.gov/getleadsafe.

On May 2, 2017, the Emeryville City Council adopted an ordinance adding Chapter 24, "Lead-Safe Renovation, Repair and Painting", to the Building Regulations in Title 8 of the Emeryville Municipal Code. The ordinance requires that the applicant for any renovation work that is regulated under Federal EPA rules submit a sworn statement that individuals performing the renovation are properly trained, renovators and firms performing the renovation are certified, and required work practices will be followed during the renovation. The applicant is also required to submit copies of certifications issued to renovators and firms performing renovations. **The ordinance takes effect May 1, 2018.** To become certified, you must take a lead renovator certification course. In-person training certifies you for five years. The City of Emeryville, in cooperation with the Alameda County Healthy Homes Department, offers the following 8-hour training course:

Why is lead such a big issue?

Lead is found in the paint on most homes in this area built before 1978 and in the soil.

Disturbing lead paint can create dangerous levels of lead dust.

It only takes a small amount of lead dust to cause serious, long-term health problems for children and adults.

Because children may be lead poisoned but show no symptoms, children under 6 years old should have a blood test for lead.

Lead poisoning is preventable!



EPA Lead RRP Certification

The EPA Lead Renovation, Repair and Painting (RRP) Rule requires that anyone working on homes, child-care facilities and schools built before 1978 be trained in and use lead-safe work practices. Firms be also be EPA lead certified.

Who does this rule apply to?

Anyone working for compensation who is disturbing painted surfaces on pre-1978 homes or child-occupied facilities. This includes contractors, landlords, maintenance companies, handymen, electricians, painters, plumbers and others.

What do I need to do to comply?

- 1) **Get trained.** You must take an 8 hour course in Lead Safety for Renovation, Repair and Painting from an EPA accredited training provider (see back panel). You will get your individual certification after successfully completing the course.
- 2) **Get Your Firm Certified.** In addition to having at least one certified individual, your firm must also submit an application and fee to EPA. Go to www.epa.gov/lead for more information.
- 3) **Lead Safe Work Practices are required.** Make sure that you practice on the job what you have learned in class.

Use Lead Safe Work Practices

Warning!

These work practices are PROHIBITED:

- Open flame burning
- Uncontained water blasting
- Using a heat gun at more than 1100°F
- Mechanical grinding/sanding without HEPA attachments

If not done properly, demolition, scraping, and sanding can create high levels of lead dust.

Firms who violate the EPA rule may be liable for civil penalties and subject to fines up to \$37,500.
